Note:-

- (i) In case of change in the allocation of work in the grades of Under Secretary, the officer shall **automatically** function as CPIO in respect of the branch allocated to the officer. Similarly, in case of any change in work allocation in the grade of Deputy Secretary/Director/Joint Director, the Appellate Authority would **automatically** undergo change accordingly.
- (ii) In the absence of any CPIO/Appellate Authority being on leave, training etc., the Link Officer concerned or the officer who looks after the charge of the post of the concerned Branch/Division would **automatically** be CPIO/Appellate Authority, as the case may be, for the allotted work. In the absence of any link officer/alternate arrangement, the Section Officer/Assistant Director dealing with the subject shall act as CPIO in respect of the Section/Unit concerned.
- 2. Sh. Sita Ram Meena, Deputy Secretary, Ministry of Power is also designated as Nodal Officer for RTI Act, 2005 in respect of RTI matters of Ministry of Power.
