G.S.R. 89.—In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the Ministry of Power Director (Operation Monitoring) Recruitment Rules, 2005 published in the Gazette of India, Part II, Section 3(i), dated the 8th June, 2005, *vide* No. G.S.R. 377(E) dated the 8th June, 2005, namely :—

1. Short title and commencement.—(1) These rules may be called the Ministry of Power Director (Operation Monitoring) Recruitment Rules, 2010.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of posts, classification and scale of pay.—The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these Rules.

3. Method of recruitment, age-limit and other qualification etc.—The method of recruitment, age-limit, qualification and other matters relating to the said post shall be as specified in columns (5) to (14) of the said Schedule.

4. Disqualification.—No person, —

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any person,

shall be eligible for appointment to the said post :

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax.—Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order, and for reasons to be recorded in writing and in consultation with the Union Public Service Commission relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving.—Nothing in these rules shall affect reservations, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Deputation (for Armed Forces Personnel—
Deputation/Re-employment)

Deputation—Officers under the Central Government —

- (a) (i) holding analogous post on regular basis in the parent Cadre/Department; or
- (ii) with five years regular service in the grade rendered after appointment thereto on regular basis in the Pay Band of Rs. 15600-39100 (PB-3) plus Grade Pay of Rs. 7600 or equivalent in the parent Cadre/Department; and
- (b) Possessing the following educational qualification and experience :
- (i) degree in Electrical Engineering from a recognized University or equivalent; and
- (ii) ten years experience in the monitoring of power grid systems.

Desirable qualifications :—

- (i) Post Graduate Degree in Electrical Engineering;
- (ii) Experience in fuel management of Thermal Power Stations.

Deputation or Re-employment of Armed Forces Personnel—The Armed Forces Personnel of the rank of Colonel or equivalent due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation term up to the date on which they are due for release from the Armed Forces, thereafter they may be continued on re-employment.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government shall ordinarily not exceed 5 years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of applications).
