

## Summary report for council of ministers on important developments in Power sector during the month of July, 2024

Important issues/developments in respect of Ministry of Power for the Month of July, 2024 are reported as under:

### Generation Performance during the month of July, 2024:

- I. The **total electricity generation** in the country during the month of July, 2024 was 1,59,554 MUs as against the generation of 1,49,062 MUs during the corresponding period last year, showing a growth of 7.04%.
- II. The electricity generation from **Fossil Fuel Power Plants** (Thermal) during July, 2024 was 1,11,310 MUs as against the generation of 1,03,175 MUs during the corresponding period last year, showing a growth of 7.88%.
- III. The overall hydro generation has decreased by 4.84% during July, 2024 as compared to last year during same period. Hydro capacity of 1806 MW (Teesta –III 1200 MW, Teesta V 510 MW and Dikchhu 96 MW) remains under complete shutdown due to flooding incidence occurred in Sikkim during October, 2023.
- IV. The Coal receipt/consumption and Coal Stock position for Thermal Power Plants in July, 2024 versus July, 2023 is: -

- V. In July, 2024, Average Biomass co-fired in NCR coal based TPPs is 2560 Tonnes Per Day (TPD), which is ~41.27% of the biomass co-firing target (i.e. 6202 TPD).
- VI. In the month of July, 2024, against a target of 941 Ckm, stringing of 1070 Ckm transmission lines were completed and further against the target of 6860 MVA, Transformation Capacity of 4360 MVA has been completed. The achievement in respect of transformation capacity is low as POWERGRID has achieved only 2000 MVA against its target of 5000 MVA for the month of July, 2024 as transformers at Narela Substation could not be charged as the Khetri-Narela transmission line is delayed due to RoW issue at Delhi & Haryana.
