## Summary report for council of ministers on important developments in Power sector during the month of JUNE, 2022

### 1. Important policy decisions taken, and major achievements during the month

- I. The total electricity generation including generation from renewable sources in the country during the month of June 2022 was 1,42,732 MU as against the generation of 1,23,550 MU during the corresponding period last year, showing a growth of 15.5%.
- II. Overall Renewable Generation (Including Hydro) has decreased by 2.7% during June 2022 as compared to last year during same period.
- III. In June, 2022, against a target of 4707Ckm, stringing of 2100 Ckm transmission lines was completed.
- IV. As on 30<sup>th</sup> June 2022, 1,615 ULBs have been enrolled and over **1.25 crore** LED street lights have been installed under Street Lighting National Programme (SLNP). Progress in this month: 29,459
- V. LED bulbs distributed under UJALA as on 30.06.2022 are 36.86 crore. Progress in this month: 7,113
- VI. Implementation of National Smart Grid Mission projects:
  - a) Meeting held under the chairmanship of Joint Secretary (Distribution) to discuss further development on Innovation Park and Incubation Center at Smart Grid Knowledge Centre (SGKC) Manesar at MoP on 15th June 2022.
  - b) In Chandigarh Sub Division 5 Project, 24,213 smart meters installed in field till date out of total sanctioned 29,433 meters.
  - c) In JVVNL (6 towns) Smart Grid project, 1,16,446 smart meters installed in field till date out of total sanctioned 1,50,000 meters.
  - d) As of June 2022, more than around 46 lakh smart meters installed in field and about 66 lakh smart meters are under deployment across various schemes/states.
  - e) EFC has recommended NSGM to be continued till 31.03.2024 at an estimated cost of Rs.136.95 Crore including GBS of Rs.45.42 Crore
