**APPOINTMENT OF CHAIRMAN, DAMODAR VALLEY CORPORATION, KOLKATA**

Damodar Valley Corporation (DVC), having its headquarters at Kolkata, is a statutory body created under the Damodar Valley Corporation Act, 1948. It is a major power and irrigation utility with a key role in the unified development of the Damodar Valley area in the States of Jharkhand and West Bengal. Chairman, DVC is the head of the DVC and is responsible for the successful implementation of the objectives of the DVC.

Applications are invited from the following eligible/interested officers of Central/ State/ Public Sector Undertakings etc. preferably having 3-5 years balance service before superannuation, for the post of Chairman DVC for a term not exceeding five years or as the Central Government may deem fit:

- (i) In respect of IAS officers, those drawing pay for at least 3 years in the Pay Band-4 + Grade Pay of Rs.10,000/- or above, who have also held the post of Secretary (Energy), Chairman, SEB or State-level Public Sector Undertakings dealing with Generation/ Transmission/Distribution. Preference will be given to those applicants who are in the Grade Pay of Rs.12,000/-.
- (ii) In respect of Engineers from Central/State Governments, those having 5 years experience in irrigation/power and those drawing pay for at least 3 years in the Pay Band-4 + Grade Pay of Rs.10,000/- or above. Preference will be given to those applicants who are in the Grade Pay of Rs.12,000/-.
- (iii) In respect of officers from the Defence Services preference will be given to those holding a rank of Major General (or equivalent) and above, having experience in Electrical and Mechanical Engineering.
- (iv) In respect of CPSUs etc. under the Ministry of Power, engineers having 5 years experience in irrigation/power and presently drawing the pay in the scale of pay of Rs.62,000/- – Rs.80,000/- or above. Preference will be given to those applicants, who are in the scale of pay of Rs.75,000/- – Rs.1,00,000/-.

(v) Joint Secretaries/Additional Secretaries, Ministry of Power, Government of India.

The applications along with bio data should be forwarded through respective cadre controlling authorities who shall enclose copies of upto date attested ACRs for the last 5 years, **to reach us by 31<sup>st</sup> January, 2011. Those who have already applied in response to the last advertisement need not apply again.**
