The pay of the officer selected on deputation will be regulated in accordance with the Department of Personnel & Training's O.M. No. 6/8/2009-Estt.(Pay.II) dated the 17th June, 2010, as amended from time to time.

- (iv) Integrity certificate (to be signed by an officer not below the rank of a Deputy Secretary to the Govt. of India);
- (v) Statement showing major/minor penalties imposed on the candidate during last ten years, if any (to be signed by an officer not below the rank of a Deputy Secretary to the Govt. of India).

4. The applications received after the last date or incomplete in any respect or those not accompanied by the information/documents as mentioned in para '3' above will not be considered. Officers who volunteer for the posts will not be permitted to withdraw their names later.

5. Eligibility : **Officers under the Central Government :**
 - (A) (i) Holding analogous post on regular basis in the parent Cadre/Department; **or**
 - (ii) with five years regular service in the grade rendered after appointment thereto on regular basis in the Pay Band of Rs. 15600-39100 (PB-3) plus Grade Pay of Rs. 7600/- (Pre-revised) or equivalent in the parent Cadre/Department; **and**
 - (B) Possessing the following qualifications and experience:
 - (i) A degree in Electrical Engineering from a recognized University or equivalent; and
 - (ii) Ten years' experience in the monitoring of Power Grid systems;
6. Re-employment - : The Armed forces personnel of the rank of Colonel or equivalent due to retire or who are to be transferred to reserve within a period of one year and having the requisite experience and qualifications prescribed shall also be considered. Such persons would be given deputation term up to the date on which they are due for release from the Armed Forces, thereafter they may be continued on re-employment.
7. Period of deputation : Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall be not exceeding 56 years as on the closing date of application

Desirable qualifications :-

- (i) Post Graduate Degree in Electrical Engineering;
- (ii) Experience in fuel management of Thermal Power Stations.
