





I. COMPANY PROFILE

SJVN Limited, a Mini Ratna: Category-I and Schedule-'A' CPSE under administrative control of Ministry of Power, Govt. of India, was incorporated on May 24, 1988 under the Companies Act, 1956 as a joint venture of the Government of India (GoI) and the Government of Himachal Pradesh (GoHP).

SJVN became a listed company in 2010, with shareholding of 55% with Govt. of India 26.85% with Govt. of Himachal Pradesh and rest 18.15% with public.

The present authorized and paid-up capital of SJVN is Rs. 7,000 crores and Rs. 3,929.80 Crore respectively as on 31.12.2023.

The Company has over the years, developed from a hydro power generator to fully diversified company in almost all fields of energy i.e. Solar, Wind, Thermal, Transmission, and Power Trading with pan India presence alongwith presence in neighboring country of Nepal.

SJVN has four wholly owned subsidiaries for development of thermal, solar, wind and hydropower in Nepal. SJVN has also two joint venture companies.

In 2008, SJVN was granted the status of 'Mini Ratna Category-I' CPSE that resulted in enhanced autonomy in decision making.

Its registered and corporate office is at Shimla.

The Company employed 1304 regular employees (Executives: 844 and Non-Executives: 460) as

on 31.03.2024.

The present Project portfolio of SJVN consists of 86 projects totaling 56662.4 MW and 3 transmission lines totaling 340 km. Eleven projects totaling 2376.5 MW and two transmission lines totaling 123 km are under operation; fifteen projects totaling 4858 MW and one transmission line of 217 km are under construction.

II. JOB DESCRIPTION AND RESPONSIBILITIES

Director (Finance) is a member of the Board of Directors and reports to Chairman and Managing Director. He is overall in charge of the finance and accounts of the organization and is responsible for evolving and formulating policies related to finance and accounts as well as implementation thereof.

III. ELIGIBILITY

2. EMPLOYMENT STATUS:

The applicant must, on the date of application, as well as on the date of interview, be employed in a regular capacity – and not in a contractual/ad-hoc capacity – in one of the followings:-

(a) Central Public Sector Enterprise (CPSE) (including a full-time functional Director in the Board of a CPSE);

(b) Central Government Group 'A' Officers including the Armed Forces of the Union and All India Services and officers from Public Sector Banks/ Financial Institutions/ Autonomous Bodies, etc;

(c) State Public Sector Enterprise (SPSE) where the annual turnover is ***Rs.2,000 crore or more**;

(d) Private Sector in company where the annual turnover is ***Rs.2,000 crore or more**.

Preference would be given to candidates from listed Companies.

(* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

3. QUALIFICATION:

The applicant should be a Chartered Accountant or Cost Accountant or a full time MBA/PGDM course having specialization in Finance with good academic record from a recognized University/Institution. Preference would be given to Chartered Accountant.

(ii) Officers of Organized Group 'A' Accounts Services [i.e. Indian Audit and Accounts Service, Indian Defence Accounts Service, Indian Railway Accounts Service, Indian Civil Accounts Service, Indian P&T Accounts & Finance Service and Indian Cost Accounts Service] working in

the appropriate level are exempted from these educational qualifications.

(iii) Further, applicants from the Central Govt./Armed Forces of the Union/All India Services, will also be exempted from the educational qualifications as per (i) above provided the applicants have 'the relevant experience' as mentioned in Para 4 (iii) below. In respect of applicants from Organized Group 'A' Accounts Services/Central Government/Armed Forces of the Union/All India Services, Chartered Accountant/Cost Accountant/MBA/PGDM will be a desirable educational qualification.

4. EXPERIENCE:

(i) The applicant should have at least five years of cumulative experience at a senior level during the last ten years in the area of Corporate Financial Management / Corporate Accounts in an organization of repute

(ii) Applicants from Organized Group 'A' Accounts Services should have at least five years cumulative experience at a senior level during the last ten years in the area of Corporate Financial Management/ Corporate Accounts.

(iii) 'The relevant experience' in respect of applicants from Central Government/Armed Forces of the Union/All India Services would include at least seven years of cumulative experience at a senior level during the last ten years in the area of Corporate Financial Management/ Corporate Accounts.

The minimum length of service required in the eligible scale will be one year for internal candidates, and two years for others as on the date of vacancy.

(i) Group 'A' officers of the Central Government including All India Services (AIS) and Autonomous Bodies etc. should be holding a post of the level of Joint Secretary in Govt. of India or carrying equivalent scale of pay on substantive basis on the date of application.

VI. UNDERTAKING BY THE APPLICANT

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
