**I. COMPANY PROFILE**

Power Grid Corporation of India Limited (PGCIL) was incorporated under the Indian Companies Act, 1956 with the mission of "Establishment and Operation of Regional and National Power Grids to facilitate transfer of electric power within and across the regions with reliability, security and economy on sound commercial principles". PGCIL, the Central Transmission Utility (CTU) of the country is a Schedule - 'A'/Navratna CPSE with the administrative jurisdiction of M/o Power.

The company employed 9217 regular employees(Executives: 4300, Non-executives: 4917) as on 31.03.2019.

Its Registered office is at New Delhi and Corporate Office at Gurgaon, Haryana.

The authorised and paid up capital of the Corporation was Rs.10000 crores and Rs.5231.59 crores respectively as on 31st March, 2019.

The Shareholding of the Government of India is 55.37%.

**II. JOB DESCRIPTION AND RESPONSIBILITIES**

Director (Projects) is a member of Board of Directors and reports to the Chairman and Managing Director. He/She is responsible for ensuring timely construction, erection, completion and commissioning of projects under the corporation as per the desired quality and cost framework through effective Project Management System.

**III. ELIGIBILITY**

## 2. EMPLOYMENT STATUS:

- Preference would be given to candidates from listed companies.**

(\* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

## 3. QUALIFICATION:

Applicant should be a graduate in Engineering or equivalent from a recognized university/institute with good academic record.

Applicants holding MBA/Post Graduate Diploma in management will have an added advantage.

## 4. EXPERIENCE:

The applicant should possess adequate experience at a senior level of management in a large organization of repute, out of which at least two years cumulative experience during the last ten years should have been in project planning/design/execution/management.

Experience in power-transmission is desirable.

## 5. PAY SCALE/ RANK/ LEVEL:

The minimum length of service required in the eligible scale/rank/level will be one year for internal candidates, and two years for others as on the date of vacancy.

**6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS**

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

**IV. DURATION OF APPOINTMENT**

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

**3. For candidates from SPSE/ Private Sector**

- a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.
- b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.

4. In the above cases, no request for relaxation or otherwise would be entertained.
