Subject: Amendment in Ministry of Power's Guidelines dated 15.10.2015 for payment of compensation towards damages in regard to RoW transmission lines and dated 16.07.2020 for payment of compensation towards damages in regard to RoW transmission lines in Urban Areas- reg.

Madam/Sir,

I am directed to say that the Ministry of Power has issued Guidelines for payment of compensation towards damages in regard to Right of Way for transmission lines vide letter No.3/7/2015-Trans, dated 15.10.2015 and another Guidelines for payment of compensation in regard to Right of Way for transmission lines, in urban areas, vide letter No. 3/4/2016-Trans, dated 16.07.2020, and to say Para 2(ii) of MoP Guidelines of 2015 and Para 3 (ii) of MoP Guidelins of 2020, stand modified as below:-
