**OFFICE MEMORANDUM**

Goods and Services Tax (GST) will be implemented in the country w.e.f. 01<sup>st</sup> July, 2017. To ensure its smooth and successful roll out, it is essential that all stakeholders both in the Government as well as outside are adequately prepared for the roll out in association with Department of Revenue. It is also imperative to ensure that all sector and businesses are GST ready.

The undersigned is directed to refer to the D.O. letter No. S.31011/15/2017-ST-IDOR dated 02.06.2017 from the Cabinet Secretary (copy enclosed), regarding creation of GST Facilitation Cell in the Ministry. In this regard the GST Facilitation Cell in the Ministry of Power is hereby constituted as follows:

3. GST Facilitation Cell would be in touch with the major industry and business associations relating to Power Sector and with CPSUs / Autonomous Bodies under Ministry of Power namely NTPC, NHPC, PGCIL, NEEPCO, THDC, SJVNL, DVC, PFC, REC, EESL, NPTI, CPRI and BEE.

4. In addition, the CPSUs/Autonomous Bodies under the administrative control of Ministry of Power vide letter dated 06.06.2017 have also been requested to constitute a 'GST Cell' in their organization. Further, GST Facilitation Cell in the respective CPSUs and Autonomous Organization would serve as the first point of contact for addressing any issue being faced by the sector.
