Summary report for council of ministers on important developments in Power sector during the month of August, 2023

Important issues/developments in respect of Ministry of Power for the Month of August, 2023 are reported as under:

Generation Performance during the month of August, 2023:

- I. The total electricity generation in the country during the month of August 2023 was 1,60,631 MU as against the generation of 1,39,769 MU during the corresponding period last year, showing a growth of 14.93%.
- II. The actual electricity generation from **Fossil Fuel Power Plants** (Thermal) during August 2023 was 1,09,969 MU as against the generation of 93,230 MU during the corresponding period last year, showing a growth of 17.95%.
- III. The Coal receipt/consumption and Coal Stock for Thermal Power Plant monitored in August, 2023 are as under:

- IV. In view of the spurt in electricity demand, Ministry of Power has further extended the direction to Imported Coal Based(ICB) Plants under section-11 of the Electricity Act, 2023, to operate and generate power at their full capacity upto 31.10.2023.
- V. Due to shortfall in rains, the storage available in the reservoirs was about 32% less, as compared to August 2022. As a result, overall hydro generation in August' 23 was 3.4% less as compared to August' 22.
- VI. In the month of August, 2023, against a target of 1514 Ckm, stringing of 330 Ckm transmission lines were completed. Less achievement in respect of transmission lines is due to non-commissioning of 669 Ckm of Telangana TRANSCO in August for RoVV issues and standing crops. In the month of August, 2023 against the target of 7385 MVA Transformation Capacity, capacity of 2515 MVA has been completed. Less achievement is primarily due to non-commissioning of North Chennai Pooling Stations of 4500 MVA by Tamil Nadu TRANSCO for technical issues. The transmission utilities are also facing delay in transformer supply due to restrictions on procuring material from companies with ownership of entities in land border sharing countries.
