Generation Performance during the month of August, 2024:

- I. The **total electricity generation** in the country during the month of August, 2024 was 1,52,993 MUs as against the generation of 1,61,167 MUs during the corresponding period last year, showing a negative growth of 5.07%.
- II. The electricity generation from **Fossil Fuel Power Plants** (Thermal) during August, 2024 was 1,04,008 MUs as against the generation of 1,10,066 MUs during the corresponding period last year, showing a negative growth of 5.50%.
- III. The overall hydro generation has decreased by 2.11% during August, 2024 as compared to last year during same period. Hydro capacity of 1806 MW [Teesta –III (1200 MW), Teesta IV (510 MW) and Dikchhu (96 MW)] remains under complete shutdown due to flooding incident occurred in Sikkim during October, 2023. Teesta Low dam-III (132 MW) is currently operating at 1/3rd capacity of its capacity due to sedimentation problem after the above mentioned flooding incidence. Further, Malana-I (86 MW) remains under complete shutdown since 1st August 2024 due to heavy flash flood in Malana river.
