Summary report for council of ministers on important developments in Power sector during the month of November, 2023

Important issues/developments in respect of Ministry of Power for the Month of November, 2023 are reported as under:

Generation Performance during the month of November, 2023:

- I. The **total electricity generation** in the country during the month of November 2023 was 1,28,691 MU as against the generation of 1,21,837 MU during the corresponding period last year, showing a growth of 5.63%.
- II. The actual electricity generation from **Fossil Fuel Power Plants** (Thermal) during November 2023 was 1,03,662 MU as against the generation of 94,463 MU during the corresponding period last year, showing a growth of 9.74%.
- III. Due to shortfall in rains, the storage available in the reservoirs was lower as compared to November, 2022. As a result, overall hydro generation in November, 23 was 30.88% less as compared to November, 2022.
- IV. The Coal receipt/consumption and Coal Stock for Thermal Power Plants monitored in November, 2023

In the month of November, 2023, against a target of 816 Ckm, stringing of 818 Ckm transmission lines were completed and against the target of 7240 MVA, Transformation Capacity of 3440 MVA has been completed. The shortfall in transformation capacity, in the month is due to delay in supply of Control Relay Panel (CRP) and other contractual issues.
- VI. Monitoring Committee of Revamped Distribution Sector Scheme (RDSS) has approved the DPR for infrastructure works for extension of distribution infrastructure to Border Areas of Arunachal Pradesh, Himachal Pradesh, Ladakh, Sikkim and Uttarakhand. State-wise details of total sanctioned cost and GBS are as under:
